**RETURNING STUDENT**

In order to make budget and enrollment provisions for the coming school year, we are presently gathering registrations for returning students. Please complete and return the **Pre-Registration form(s) and the Registration Fee (\$75 per child up to 4 children with a cap of \$250) by Friday, January 20, 2012**. It is important that you return this form even if your plans are uncertain at this time so we can hold a place for your child. If we do not receive a form for your child we will assume you are not returning. **Pre-registration for siblings of currently enrolled students and new students will begin on Monday, February 6th. Forms will be available in the office at that time.**

Read carefully and give all information that pertains to your registration. We request that you **COMPLETE A SEPARATE FORM FOR EACH CHILD YOU ARE REGISTERING.**

All newly enrolled students entering Kindergarten and First Grade are given the Gesell Readiness Assessment before enrollment. Kindergarten applicants currently enrolled in St. Charles Preschool may choose to waive this assessment, if desired, however, students with a birthday past August 1, will be required to take the Gesell Assessment. A parent information session about the Gesell Assessment will be held on Sunday, March 25, at 11:15 a.m. in room 109 of the school. The assessments will take place March 27, 28 and 29th. **A \$25.00 Assessment fee is due at the time the child is assessed.**

**The Registration Fee (which is Non-Refundable) is due by January 20, 2012. Any special circumstances should be discussed with the principal prior to this date.** The first tuition payment is due in August. Semi-annual and annual payments may be made by check; monthly payments are automatically withdrawn from your checking account. A new Fee Schedule will be established by the School Commission in May 2012.

**All accounts, (registration fee, book fee, and tuition) must be made current before a place will be held for your child.**
